# FUNDING FOR NORTH DAKOTA'S LONG-TERM CARE CONTINUUM SERVICES

This memorandum provides information regarding the funding and inflationary increases provided for the long-term care services programs, including nursing home care, basic care, and home- and community-based services, including information regarding the service payments for the elderly and disabled (SPED) sliding fee schedule.

### LONG-TERM CARE CONTINUUM - SERVICES

North Dakota's long-term care continuum includes various medical and support services for individuals that lack some capacity for self-care, and are expected to need care for an extended period of time. The following is a summary of programs that are included within the state's long-term care continuum:

- Nursing home care Provides facility-based residential care to individuals who, because of impaired capacity for independent living, require 24-hour-aday medical or nursing services and personal and social services.
- Basic care Provides facility-based residential care to individuals who, because of impaired capacity for independent living, require health, social, or personal care services, but not 24-hour-a-day medical or nursing services.
- Home- and community-based services Provides services to assist individuals to remain in their homes and communities. Services include the following:

**Service payments for elderly and disabled** - Provides in-home and community-based care to individuals who are impaired in at least four activities of daily living (examples include toileting, transferring, eating, etc.) or at least five instrumental activities of daily living (examples include meal preparation, housework, laundry, medication assistance, etc.). Services available include adult family foster care, case management, chore services, emergency response system (Lifeline), environmental modification, family home care, homemaker services, personal care, and respite care.

**Expanded SPED** - Provides in-home and community-based care to individuals who are not severely impaired in activities of daily living (examples include toileting, transferring, eating, etc.), but who are impaired in at least three of the four following activities of daily living--meal preparation, housework, laundry, and medication assistance, or who have health, welfare, or safety needs, including requiring supervision or a structured environment. This program is an alternative to basic care. The individual must be Medicaid-eligible to receive services under this program. Services include adult family foster care, case management, chore services, emergency response system (Lifeline), environmental modification, family home care, homemaker services, and respite care.

**Personal care services** - Provides in-home care to individuals who are impaired in at least one activity of daily living (examples include toileting, transferring, eating, etc.) or in at least three of the four following instrumental activities of daily living--meal preparation, housework, laundry, and medication assistance. The individual must be Medicaid-eligible to receive personal care services. These services include assistance with bathing, dressing, toileting, transferring, eating, mobility, and incontinence care and also assistance with meal preparation, housework, laundry, and medication assistance.

**Medicaid waiver for the aged and disabled** - Provides in-home and community-based care to individuals who otherwise would require nursing home care and who are Medicaid-eligible. Services available include adult day care, adult family foster care, case management, chore service, emergency response system, environmental modification, homemaker services, nonmedical transportation, residential care, respite care, specialized equipment and supplies, supported employment services, and transitional living services.

**Technology dependent Medicaid waiver** - Provides attendant care and case management services to individuals under the technology dependent Medicaid waiver if the individual is Medicaid-eligible and meets the following functional criteria:

Meets level of care screening criteria.

Vent-dependent at least 20 hours per day.

Medically stable.

Has an informal caregiver system for contingency planning.

Is competent to participate in planning.

If under age 65, the disability must meet Social Security criteria or determined to be physically disabled by the state review team.

**Other services** - Other home- and community-based services, include the children's medically fragile waiver, children's hospice waiver, targeted case management, autism, and the program for all-inclusive care for the elderly.

### LONG-TERM CARE SERVICES - FUNDING

The following schedule summarizes inflationary increases approved by the Legislative Assembly for the 2009-11 biennium through the 2015-17 biennium for human service providers.

## SPED SLIDING FEE SCHEDULE - IF UPDATED WITH 21 PERCENT INFLATIONARY INCREASE

The appendices present the SPED program sliding fee schedule with a 21 percent inflationary increase for a family with assets of between \$0 and \$24,999 (<u>Appendix A</u>) and for a family with assets of between \$25,000 and \$50,000 (<u>Appendix B</u>) as provided by the Department of Human Services. The department estimates an additional \$1.53 million from the general fund would be needed to increase the SPED program sliding fee schedule by 21 percent.
